FEDERALISM AND FUNDAMENTAL RIGHTS

The aim of the Winter School 2013 is to better understand the challenging and largely unexplored link between federalism and protection of fundamental rights from a multi-disciplinary perspective, providing in-depth analysis and practical knowledge of the instruments, the problems and the solutions available in this field. Several case studies from all continents will be presented and discussed by both academics and practitioners who manage these issues on a daily basis. Additional workshops will give participants the opportunity to discuss highly topical issues of federalism and fundamental rights.

The Winter School will provide response to questions such as: to what extent is territorially differentiated protection of fundamental rights possible and even desirable? What fundamental rights are best suited to be developed differently in different parts of a state's territory? What lessons can be learned from comparative practice? How can federal, regional or devolved forms of government be used to improve rather than limit the enjoyment of fundamental human rights? What do international standards and practice have to say in this regard?

WHAT IS THE WINTER SCHOOL ABOUT?

The Winter School is a postgraduate programme offering a broad range of courses on federalism and governance. It enables researchers, post-doctoral students and practitioners to extend and deepen their knowledge in multilevel government and governance, especially from a legal and political science perspective.

The 2013 edition of the Winter School focuses on the topic of “Federalism and Fundamental Rights”. Federalism, regionalism, devolution, autonomy and other forms of territorial division of power are key tools for effective and democratic governance. They are often used to address fundamental rights issues, mostly in an effort to better promote and protect them, but also, in some instances, to limit them. The link between federalism and fundamental rights is still largely unexplored. The Winter School 2013 provides answers to a series of issues by combining high-level expertise and problem-oriented approaches.

WHO CAN PARTICIPATE?

The Winter School is designed for applicants who wish to develop and upgrade their knowledge by applying an interdisciplinary and comparative approach:

- young researchers and academics
- post-docs, post-graduate and undergraduate students
- civil servants from a local, regional or national government
- employees of international organisations or NGOs

Please note that the programme builds on assumed prior knowledge in the area of “Federalism and Fundamental Rights”.

WHAT TO EXPECT?

The 10-day programme offers all participants a challenging international learning environment. It takes place during one week in Austria (Innsbruck) and one week in Italy (Bolzano/Bozen, South Tyrol) and includes:

- lectures by renowned academics from Europe, North America, Asia, Africa and Australia;
- discussions and case studies with experts from international administrations and judicial bodies;
- institutional study visits with politicians and a public lecture in Bolzano/Bozen.

Successful participants of the programme are awarded 10 ECTS credits.

The working language is English.
