*The rights of peoples, the right to self-determination, the right to peace, the right to development and the right to permanent sovereignty over natural resources.
A bibliography*

This bibliography refers to the rights of peoples, to the relationship between these rights and human rights, and to some of the rights which, in recent years, have been described as the rights of peoples, such as the right to self-determination, the right to permanent sovereignty over natural resources, the right to development and the right to peace.

This is an updating and re-formulation of the bibliography published in the report I prepared for the Subcommission on Prevention of Discrimination and Protection of Minorities on "The Right to Self-determination: The Implementation of United Nations Resolutions", United Nations, published in New York in 1979 (E/CN.4/Sub.2/405/Rev. 1), (Sales No. 79, XIV. 5).

The subject of the rights of peoples – their nature, the relationship between collective rights and individual rights (in so far as their beneficiaries are human beings, they include not only civil and political rights, but also economic, social and cultural rights), the link between the rights of peoples and human rights, and all matters regarding the various rights that have been understood as rights of peoples – is one that has undergone intensive and controversial changes in approach in recent years. In fact, the legal issues raised by these rights, the differences between the way in which they are viewed at present and the traditional position of legal doctrine – which as a result has undergone undeniably profound changes – the political problems very often involved, the relationship between people's rights and both the ideas underlying the promotion of a New International Economic Order and the struggle against colonialism and neo-imperialism, all this has made for impassioned debate on the subject of people's rights. It cannot be denied that the general theme of the rights of peoples and their relationship with human rights and the rights to self-determination, development, permanent sovereignty over natural wealth and resources, and peace, is currently one of the most dynamic aspects of modern international law. It figures prominently among the subjects that *per se* and in their bearing on other essential components of the current Law of Nations – such as the definition of the subject in international law, the equality and sovereignty of States, prohibition of the use of force in international relations, international interdependence and solidarity – are a central focus of legal and political attention. It can be asserted that, to a large

extent, the way in which these themes are developed will condition, in the juridical sphere, the content and limits of international law in the future.

Unesco has devoted special attention to the study of these new problems, and several of its initiatives, seminars and publications involve them in one form or another. We only wish to recall here, among the works published by Unesco on the subject, the already classic book by Mohammed Bejaoui, *Towards a New International Economic Order* (Unesco, Paris, 1979)¹, the documents and report of the Expert Meeting on Human Rights, Human Needs and the Establishment of a New International Economic Order (Paris, 19-23 June 1973), and the International Expert Meeting on the Problems Connected with the Rights of Peoples and the Historical and Practical Significance of the Problems (Harare, Zimbabwe, 2-5 December 1985).

There is thus a wealth of bibliographic material. But as a result precisely of this, and of the universal interest in the topics involved, studies in this field are published in most of the member countries of the United Nations and of Unesco, making it difficult to draw up a list that has any hope of being comprehensive.

This difficulty increases when, as in the present case, the preparation of the bibliography is an individual undertaking and not a piece of collective research work the results of which are made known after painstaking searches in all the world's major libraries.

For this reason, the reader's indulgence is requested for all the omissions and shortcomings of this work. It is subject to the unavoidable limitations of an individual undertaking, carried out, what is more, in a very short space of time.

Despite its shortcomings, however, we feel that this bibliography could be useful, not only because it is a compendium of references to books, studies, monographs and articles that are clearly important for these subjects of major current interest – an interest which presumably will increase in the coming years – but also because further suggestions are sure to be forthcoming, which will enable it to be expanded and improved.
