Purpose of the Meeting

The First Transnational Meeting in Nice, scheduled to take place at the end of the research activity carried out in the 4 Countries involved, is aimed at:

- a) Joint analysis and exchange of research results on the phenomenon of trafficking for the purpose of exploitation in illegal activities in the 4 Countries involved (Italy, France, Hungary and Romania). The meeting aims at presenting the fundamental elements of the research carried out at Country level and at debating with project partners and stakeholders the contents, specificities, areas of concerns with regards to the phenomenon.
- b) Introduction of national intervention systems and operating procedures in place in the involved countries, in particular relation to situations of severe exploitation connected to forced criminal activities;
- c) Identification of agency-specific and multi-agency best practices about recognition-identification, referral and assistance of victims, in particularly about Roma minors;
- d) Identification of transferability criteria of detected best practices in order to set up a prototype for agency-specific and multi-agency practices in recognition-identification, referral and assistance;
- e) Definition of the planning and the methodology of multi-agency training to be carried out in the following months.
