### ***Purpose of the Joint Transnational Meeting***

The TEMVI Second **Joint Transnational Meeting**, taking place in Budapest on the 29th of May, placed between the end of the research activity on the phenomenon and the practices carried out in the 4 involved countries and the implementation of the multi-agency training to take place in each country in Autumn 2015, is aimed at:

- a) Discussing among relevant professionals from different key-agencies the proposal of an agency-specific and multi-agency human rights-based Transnational Prototype of referral practices and procedures for the identification and protection of persons trafficked into forced criminal activities (with also a specific focus on minors and on Roma people);
- b) Providing input about the planning and implementation of the multi-agency training to be carried out between August and November in each country; the multi-agency training courses, addressing social and law enforcement key-professionals, are aimed at increasing and exchanging knowledge about trafficking into forced criminal activities and at developing identification, referral, protection and assistance measures and procedures for persons trafficked into forced criminal activities.

### ***Purpose of the Project International Committee Meeting***

The TEMVI **Project International Committee**, taking place in Budapest on the 30<sup>th</sup> of May is aimed at:

- a) Validation of the final research reports about phenomenon and practices; features of the publications and dissemination;
- b) Definition of the finalization process of the Prototype, based on the discussions held in the Joint Transnational Meeting;
- c) Discussion and validation of the multi-agency training (structure, objectives, participants, topics, methodology, tools and materials, calendar) and identification of consequent implementation planning steps. Preliminary discussion about the 2 multi-agency workshops to be held in each country for the development of multi-agency operational protocols;
- d) Monitoring and evaluation;
- e) Analysis of administrative and budget issues.
- f) Planning of the next meeting, to take place in Romania in December 2015.



### *Notes on Budapest Meeting*

According to the aim of the TEMVI Project as regards the definition of multi-agency operational protocols, the main objectives are:

- To evaluate the work in a networking multi-agency key also in relation to those trafficking conditions that have not always been treated up to now, using adequately devices and policy systems as provided at the national and European level.
- To strengthen multi-agency work and the cooperation between social intervention area workers and police about the recognition-identification, the warning-sending (reporting to the police or social services or NGOs) and the first assistance to Roma minors involved in forced criminal activities.
- To identify operational practices and rules of conduct concerning recognition-identification, the warning-sending (reporting to the police or social services or NGOs) and the immediate assistance of Roma minors involved in forced criminal activities.

To finalize the construction of a transnational prototype (agency-specific and multi-agency) of best practices on recognition-identification, referral and protection it is necessary to verify its operational potential implementation with a larger spectrum of stakeholders. An added staff member of the Municipality of Venice will attend the Joint Transnational Meeting and the session of the Project International Committee. The expertise of this Staff Member who normally manages the Italian National Helpline for victims of trafficking will be very useful to suggest the improvement of all phases of the operational procedures that the prototype can contribute to plan at national level.

The meeting of the Project International Committee will also be attended by an external participant per country (as in Nizza – 1 additional participant for each State involved in the Project) in order to work with an multi-agency approach in debating the validation of the final research reports about phenomenon and practices, the finalization of the Prototype, the implementation of the training.

The presence of different stakeholders during this PIC can contribute to increase the level of knowledge about the specificity of this target group in trafficking situation and to better organize the training activity in each country that represents the next step of the TEMVI Project.
