#### II. Outcomes

In the considered period, the Chair continued developing its links with regional and national institutions such as Region of Veneto.

As regards the university system, in particular the University of Padua, the UNESCO Chair is consolidating its complementary role with respect to the Interdepartmental Centre on Human Rights and the Rights of Peoples in carrying out educational and educational activities.

It actively participates in the didactical and scientific management of two major Courses of the Faculty of Political Science: the (three-year) Course in "Political Science-International Relations-Human Rights" (BA, 350 students per year) and the two-year advanced Master in "Institutions and Politics of Human Rights and Peace" (MA, 80 students per year).

## III. Forthcoming activities

*At the institutional level:* 

Cooperation with the Veneto Region and with the Ministry for Human Rights and Equal Opportunities.

In the field of research, there will be a special emphasis on the following subjects:

- Peace and human rights in the university teaching
- 'City Diplomacy', subsidiarity, human rights, positive peace;
- Human security and human rights dimension of peace operations;

- Human security and gender mainstreaming;
- Peace as human right;
- Peace and children political and social rights;
- countering the states attempt to reappropriate the jus ad bellum

# IV. Development prospects

The UNESCO Chair is 'structurally' placed in the institutional framework of the University of Padua-Interdepartmental Centre on Human Rights and the Rights of Peoples. That is within a public institution with all relating warranties. In this context the UNESCO Chair has prestigious visibility and consideration.

Its functioning should be considered as fully long-term sustainable.
