LEGAL ANSWER

Penal Code> trafficking was confused with smuggling Spanish: trata/ tráfico

Inmigration law> 59 art. Some protection conditioned to collaboration with authorities





Informal collaboration and limitated to specific areas and low enforcement







5th good practice > collaboration in REPATRIATION

IOM Special Program Voluntary repatriation

Trafficking victim has priority in case of repatriation (from a week to a month)

Sometimes and in some countries it's taken into consideration the risk assessment and our NGO can facilitate local NGO contact to the victims.

Embassy collaboration: Rumania

Informal collaboration and limitated to specific areas and low enforcement





SHOULD BE A GOOD PRACTICE: PROTOCOL OF COLLABORATION WITH NGO IN THE IDENTIFICATION

It's written in law but not implemented

The unique responsible for the identification is the POLICE

An informal collaboration is steal working based on the confidence between the specific police and NGO

GOVERMENT HAS A STRONG DISTRUST OF THE NGO BECASUSE OF A POTENCIAL ABUSE TO OBTAIN THE RESIDENCE PERMISSION







SHOULD BE A GOOD PRACTICE: SOCIAL FORUM AGAINST SEXUAL TRAFFICKING

Members: Government (9 Ministries; 2 regional Gov, Municipality Federation and civil society)

It's supposed to be a coordination tool

Spanish network proposed a working group to analysis how to implement the new law through the main difficulties for the victims

NOW IT IS JUST USEFULL FOR THE GOVERMENT, NETWORK IS ABOUT TO GIVE UP







SHOULD BE A GOOD PRACTICE:

DATA ABOUT TRAFFCKING

2010 1st official data

Police data: 1.300 victims; 6.000 potential victims, origin countries

(Rumania, Brasil, xxx detentions)

No single indicator about protecting human right s

WITHOUT DATA INDICATOR ON HR IS NOT POSSIBLE TO KNOW THE REAL VICTIM PROTECTION







SHOULD BE A GOOD PRACTICE: NEW ASYLUM LAW

2009 new asylum law recognizes the possibility to ask for international protection based on gender.

Trafficking is a reason to ask for protection in certain cases based on a personal situation of the victim.

All cases are denied before admitting

GOVERMENT HAS TO CLARIFY THE INTERPRETATION OF THIS LAW







SHOULD BE A GOOD PRACTICE:

NEW INMIGRATION LAW: NGO AND DETENTION CENTERS

- •2009 Immigration law recognized the NGO right to enter in the detention center.
- No jet implementing (It needs to development in a regulation)
- •In Madrid center all women come from raids in prostitution
- Mostly of them are under risk of expulsion without guarantees.
- •New police indication for the reflection period: a possible victim should not be in a detention center...

DETENTION CENTER IS A IMPORTANT PLACE TO IDENTIFIED AND SUPPORT VICTIMS. THE NGO SHOULD BE WORKING THERE







SHOULD BE A GOOD PRACTICE: THE CORDINATOR ROLL OF THE MINISTER OF EQUALITY

Integral plan against sexual trafficking is coordinated by the Equality Ministry

It's a new Ministry without resources

Equality is the contact for us but decision maker are in Domestic Affair Ministry

THE ADD VALUE OF THE EQUALITY MINSTRY MUST BE MORE CLEAR AND IMPORTANT
