#### 1. Executive Summary:

Major outcomes, results and impact of the Chair, including on national policies, in relation to its objectives as stated in Article 2 of the Chair Agreement (between the Institution and UNESCO)

(Not exceeding 300 words)

In the period following the 2012 report, the Chair carried out its activities with regard to both academic and non-academic targets, as presented in the specific sections of this form.

Within the Academia, the main goal has been to further develop and consolidate human rights mainstreaming in teaching courses and research, through mutually reinforcing cooperation with the Human Rights Centre of the University of Padova. In 2013 the Centre, also by virtue of the prestige derived by hosting the Chair, was improved from "Interdepartmental" Centre (*Centro Interdipartimentale*) to "University" Centre (*Centro di Ateneo*), reaching the same institutional position of the Botanic Garden of the Padua University, which is UNESCO World Heritage. Accordingly to the new statute of the University Centre, the UNESCO Chair is *ex officio* member of the Centre's Board. The Chair actively contributed to a) transforming the 2-year Degree Course in 'Istituzioni e Politiche dei diritti umani e della pace' (Institutions and policies of human rights and peace) into the M.A. in 'Human Rights and Multi-level Governance', entirely taught in English and active from the A.Y. 13-14, and b) establishing, in 2015, the International Ph.D conferring a Joint Degree in 'Human Rights, Society and Multi-level Governance' (partner universities: Zagreb, Athens-Panteion, Western Sydney).

A major research activity undertaken with continuity since 2011 is the preparation of the

Italian Yearbook of Human Rights (Italian and English editions), which has brought a significant impact on the external relations of the Chair, both with the Italian Government (especially the Ministry of Foreign Affairs), Parliament (both the Chamber of Deputies and the Senate), and with international institutions, namely UNESCO, the UN Human Rights Council, OHCHR, the Council of Europe and the EU. The Yearbook is annually presented in Rome and has helped developing fruitful relations especially with the Inter-Ministerial Committee for Human Rights and its Director.

Within the EU context, the Chair holder actively participated to the preparation of the Committee of the Regions' European Charter on Multi-level Governance, fostering human rights mainstreaming and highlighting the relevance of human rights-based global citizenship (see reference in CDR 4527/2014, item 24).

In 2013, the Chair, jointly with the Human Rights Centre and the Italian Coordinating-Body of Local Authorities for Peace and Human Rights promoted a Campaign for the international recognition of the right to peace as a human and peoples' right, which has engaged so far more than 300 local authorities and several NGOs. In close cooperation with the Legal Advisor of the Chairman-Rapporteur of the Intergovernmental Working Group on the Right to Peace of the UN Human Rights Council, the Chair contributed to publish a special issue in English of the Review 'Pace Diritti Umani/Peace Human Rights', which was distributed to all Council members in 2014.

On the occasion of the celebrations for the 800<sup>th</sup> anniversary of the Magna Charta, the Music Theatre entitled 'We, Human Rights, Representation of Human Dignity and Peace', written by the UNESCO Chairholder, was presented in Padua in June 2015 and then taken to schools throughout Italy.

On 24-25 March 2015, the Chair presented a paper during the Paris Expert Meeting on the 'International Decade for the Rapprochement of Cultures (2013-2022). On initiative of the Chair, the Human Rights Centre contributed financially to the publication of the volume 'Agree to Differ', which includes an essay by the Chair holder.

# a) Education/Training/Research

# i) Education (leading to certificate)

# Master Degree Programme in Human Rights and Multi-level Governance

A.Papisca, Teaching course on "International Organisation for Human Rights and Peace" (6 ECTS), a.y. 2012/2013 e 2013/2014.

The Master's degree course provides students with the knowledge and the competences required to protect and promote human rights in multi-level governance contexts, locally to internationally. Students develop the capabilities and skills necessary to analyse, assess and manage complex political and socio-economic phenomena and their impact on the fundamental rights of all persons, mainly the most vulnerable ones. The scientific and value-based paradigm adopted is rooted in the principles of the international law of human rights, according to a trans-national and trans-cultural approach. The

course is inherently multi-disciplinary and nurtures students' interdisciplinary abilities.

The normal duration of the course is two years and requires 120 university credits (or CFUs). The Master degree in Human Rights and Multi-level Governance will be awarded upon completion of the course. All teaching courses are taught in English.

# European Master Degree in Human Rights and Democratisation (E.MA) e European Inter-University Centre for Human Rights and Democratisation (EIUC).

The E.MA is the main teaching programme of the European Inter-University for Human Rights and Democratisation, located in Venice. Established in 1997 thanks to the vision of 10 pioneer universities led by the Padua University, E.MA is the oldest Master's programme supported by the European Union, which aims at preparing human rights professionals to respond to the operational requirements of daily work in international organisations, field operations, governmental and non-governmental bodies and academia. The multidisciplinary E.MA teaching programme is articulated in two semesters. During the first semester the activities will be based in Venice, where students will attend lectures and actively participate in seminars and workshops, thematic clusters, skills-building sessions and project work. While studying in a multicultural environment, students will have the opportunity to be taught by leading academics, officials of international organisations and experts and practitioners of national and international NGOs. During the second semester, students will relocate to one of the 41 participating universities to follow courses in an area of specialisation of their own choice and undertake personal supervised research finalised to the writing of their Master's thesis. The University of Padua is the first enrollement university for the E.MA students.

# Joint Ph.D Degree in "Human Rights, Society, and Multi-level Governance"

The Joint Ph.D Degree in "Human Rights, Society, and Multi-level Governance" is a three-year, interdisciplinary, joint academic programme managed by Universities in Australia, Croatia, Greece, Italy, coordinated by the Human Rights Centre of the University of Padova (Italy). The doctorate aims at forming researchers with a multi/interdisciplinary profile. The programme includes teaching, research and training in the area of human rights studies, covering the various legal, political, social, philosophical and economic approaches and methodologies, and different geographical areas. The language of the programme is English. Students undertake research, take courses and do internships at the University of first enrolment (Home University), and at one or more of the other partner Universities (Host Universities), where they have to spend at least one semester.

# **Music and Human Rights Seminars**

The organisation of these seminars, which will be delivered for the first time to the Padova's human rights students in the Spring of 2016, is the direct outcome of a fruitful cooperation between the Chair and 'Musician for Human Rights', an international NGO, founded in 2009 by world-renowned musicians, which aims to promote a culture of humanism through music worldwide, in support of the Universal Declaration of Human Rights. The seminars include, among others, the following lectures: The Yin and Yang of Music and Human Rights; Ascoltare o Sentire: The Art of Knowledge; The Sound of Human Rights; One and Many Voices: Unity through diversity and interdependence; Fountain or Stone?: The Spirit of the Law and The Letter of the Law; From Refugee to Refuge: Self-discovery, opportunity, and transformation: an empirical case; Brainwashing, War, and Torture: Music as Weapon.

# **General Training of National Civil Service Volunteers**

Since 2008, the Chair has been involved in developing the training modules (2-3 year each) for the about 120 volunteers that, every year, are selected to participate into the projects offered by the University of Padova in the framework of the National Civil Service (established with Italian law 64/2001). The specific contribution of the Chair in this context is in mainstreaming human rights within the subjects taught to these volunteers. The modules introduced by the Chair and the Human Rights Centre include: 'The National Civil Service Volunteer as a Model of Human Rights Defender'; 'Constitutional and Universal principles on human rights, peace and solidarity'; 'New Humanism and the right to take part in cultural life'; 'Intercultural Dialogue and Citizenship in the Inclusive City', 'Cultural Rights: Protection of the Cultural Heritage and Cultural Goods Rights'.

# 4th Cycle of seminars on the theme "Urban Security and Human Rights"

The cycle of seminars, held in Spring 2013, has been aimed at, among others, making the training experience of the MA Programme in human rights of the University of Padova increasingly practice-oriented and developing positive synergies among two institutions which are daily committed in the promotion of the respect of national and international law, human rights, the rule of law, democratic principles and non-discrimination. Thus, Police and University work together to promote a genuine civic education intended as a priority way to build a safe, polite and convivial city up. The group of learners have been composed by Police officers and MA students.

# iii) Research

The research activity of the UNESCO Chair supported by the University Human Rights Centre has been pursuing, since the beginning, the purpose to contribute to the deepening and the dissemination of the culture of peace-human rights-democracy starting from the premise that 'human rights knowledge' is a peace-values- and action-oriented and constitutionally inter- and multi-disciplinary knowledge.

# e) Cooperation with UNESCO Headquarters, Field Offices

Three professors of the University of Padova participated in the Expert Meeting on International Decade for the Rapprochement of Cultures (2013-2022): Antonio Papisca, UNESCO Chair 'Human Rights, Democracy and Peace', Marco Mascia, Director of the University Human Rights Centre, and Léonce Bekemans, Academic Coordinator of the Jean Monnet European Centre of Excellence 'Intercultural Dialogue, Human Rights and Multi-Level Governance'.

The Meeting, which provided the opportunity for launching the International Decade for the Rapprochement of Cultures, took place from 24 to 25 March 2015 at the UNESCO Headquarters in Paris. This has been a key step ahead of the follow-up to the United Nations General Assembly Resolution 67/104 of 2012, entitled "Promotion of interreligious and intercultural dialogue, understanding and cooperation for peace", which proclaimed the International Decade for the period from 2013 to 2022. The Expert Meeting contributed to provide concrete guidance and the necessary recommendations to help chart a road map with clear targets and traceable results to be achieved with a view to make the "Rapprochement of Cultures" a tangible progressive reality.

# International Campaign for the recognition of the human right to peace

Since 2012, many Town Councils in several Italian Regions started to adopt a petitionary motion supporting the ongoing work of the Human Rights Council for the recognition of the right to peace as a right of the person and of peoples. The text of the motion was drawn up by the UNESCO Chair together with the Human Rights Centre has been distributed over a large portion of Italy by the National Coordinating-Body of Local Authorities for Peace and Human Rights. It has been a bottom-up mobilisation, perfectly consistent with the principle of subsidiarity. The aim has been to collect all these motions and submit them to the UN Human Rights Council. This city diplomacy initiative of Italian local authorities has joined the International Campaign for the recognition of the human right to peace, promoted by the Human Rights Centre and the UNESCO Chair "Human Rights, Democracy and Peace" of the University of Padova, by the Franciscan Order of the Sacro Convento di San Francesco di Assisi, by the aforementioned National Coordinating Body of Local Authorities, the Peace Roundtable (Tavola della Pace) and the Peace Network PerugiaAssisi.

# Outcomes of the Campaign in the period 2012-2015

On joint initiative of the Human Rights Centre, the UNESCO Chair and the National Coordinating Body, 100 Municipal Councils of big and small Italian cities - from Sondrio to Ragusa, from Rovereto to Crotone, from Reggio Emilia to Naples, from Ferentino (Frosinone) to Noci (Bari), from Este (Padua) to Ponte San Nicolò (Padua) - have so far adopted a petitionary motion for the international recognition of the human right to peace. Also the Regional Council of Veneto has approved the same petitionary motion.

The Italian Municipalities have shown a direct interest in the debate under way in Geneva due also to the fact that most of their Statutes include a norm which, referring at the same time to the Italian Constitution and to the International Human Rights Law, recognises peace as a fundamental right of individuals and peoples (the so called "peace and human

rights norm"): this situation is still a unique case in the world. In this sense, the Italian subnational legislation is preceding the formal international process of standard settingon the subject.

Strengthened by this original legitimation, which has also a symbolic impact, and referring to Article 1 of the "United Nations Declaration on the Right and Responsibility of Individuals, Groups and Organs of Society to promote and protect Universally Recognized Human Rights and Fundamental Freedoms", a delegation of Mayors representing the City Councils that have adopted the above-mentioned petitionary motion have been to Geneva, at the *Palais des Nations*, on Monday 23 June, in order to deliver a copy of the Councils' deliberations to Ambassador Christian Guillermet, President of the intergovernmental Human Rights Council Working Group, to Ambassador Maurizio Enrico Serra, Permanent Representative of Italy to the United Nations, to the Representative of the United Nations High Commissioner for Human Rights, and to H.E. Mons. Silvano M. Tomasi, Permanent Observer of the Holy See to the United Nations.

On the occasion of the meeting "L'Italia per il diritto alla pace" (Italy for the Right to Peace), Thursday 3 July 2014 at the Senate of the Republic, Sala Capitolare, a delegation of local administrators have delivered the first 100 deliberations approved by the Italian local authorities in favour of the international recognition of the human right to peace and the appeal endorsed by hundreds of Italian secular and religious figures to the President of the Human Rights Commission of the Senate Luigi Manconi and to the other attending authorities.

A group of fifty students and National Civil Service Volunteers of the University of Padova, coordinated by the Human Rights Centre and the UNESCO Chair, participated in the Peace March Perugia-Assisi on 19 October 2014. The students and the volunteers walked the whole route from Perugia to Assisi, carrying with them twenty-eight posters bearing the words: Human Right to Peace in twenty-eight languages, in support of the International Campaign for the recognition of the human right to peace.

In particular, the students and the volunteers played a very important role during a special moment in front of the Church of San Francesco in Assisi. On that occasion two young volunteers of the University of Padova, surrounded by 50 Mayors, read an Appeal, written by the Human Rights Centre, starting with:" We, the members of the human family and of the peoples of the United Nations, have the Right to Peace".

# 3. Future Plans and Development Prospects:

Outline of action plan for the next biennium and short/medium and long-term development prospects. Please do not hesitate to refer to difficulties that the Chair has experienced (Not exceeding 300 words)

In the next biennium, the Chair aims to continue its research, education and information activities in the field of human rights, democracy and peace consistent with what has been done in the period covered by this report. In particular, the Chair will develop its action according to the following prospects:

- Expanding current research and training to support the international campaign for the recognition of the right to peace as a fundamental human and peoples' right, and strengthening the cooperation with Italian and international local authorities to reinforce advocacy, documentation and outreach activities on this matter at the national, European and UN level;
- Consolidating further the promotion of human rights mainstreaming in both formal and non-formal education activities promoted by the University of Padova, as well as by other academic partners and NGOs. Formal education programmes to which the Chair will directly contribute include the MA Degree Programme in Human Rights and Multi-level Governance and the recently launched Joint International Ph.D Programme in Human Rights, Society and Multi-Level Governance. Non-formal activities include the training of the National Civil Service Volunteers at the University of Padova, cooperation initiatives with the schools of the Veneto area; and further cooperation with Musicians for Human Rights with a view to expand and consolidate the seminar offer on 'Music and Human Rights'.
- Continuing research activity linked to the publication of the Italian Yearbook of Human Rights, with related presentations in Rome, before national institutions, including the Constitutional and the Supreme Courts; establishing a network of national human rights yearbooks based on the methodology applied to the Italian Yearbook, with a primary view to spreading further a culture of human rights among public authorities both in Italy and in other countries where the Chair has developed cooperation ventures.
- Contributing actively to conferences and seminars on human rights, democracy and peace. In 2016, in particular, the Chair will organise, together with the Human Rights Centre, a conference to celebrate the 50<sup>th</sup> anniversary of the adoption of the two International Covenants of 1966, which will be anticipated by the formatiom of a group of trainers to train educators about the effectivity of the Universal Bill of Human Rights. The Chair will also present a paper at the 2016 Conference of the Italian University Association of European Studies (AUSE) on the advocacy for a uniform European law on citizenship.
- Contributing to the International Decade of the Rapprochement of Cultures, through the promotion of initiatives focused on plural citizenship and on the promotion of a human rights-based approach to intercultural dialogue.
- Taking the music theatre 'We, Human Rights. Representation of Human Dignity and Peace' (both in Italian and in English) in theatres and schools throughout Italy and Europe.
- Contributing to research and training activities of the Human Rights Centre within the framework of the programme 'ADPOLIS Anti Discrimination Policies Successfully Implemented' (2016-2018), coordinated by ETC Graz, of which UNESCO is associate partner.
- Expanding the section of the website of the Human Rights Centre of the devoted to the Chair, in order to archive all past research, education, information activities of the Chair and provide more visibility to this institution and its future prospects.
