UNESCO Chair "Human Rights, Democracy and Peace" 2016-2018 Activities

(Unesco Chairs Meeting, Rome 24 May 2017)

The Chair's research and education programmes place their specific emphasis on how to increase the effectiveness of the instruments that constitute the Universal Bill of Human Rights, with particular attention also to some soft law instruments, such as the UN Declaration on human rights education and training (2011), the UN Declaration on the right and responsibility of individuals, groups and organs of society to promote and protect universally recognized human rights and fundamental freedoms (1998), the UN Declaration on the right to peace (2016), and certainly the UNESCO programmes on Education for sustainable development and Global citizenship education.

The Chair's activities are marked by an approach which is strongly policy- and actionoriented and by a continuing exchange and cooperation with three 'vital worlds': civil society organisations, local governments institutions, and the school.

The reputation of the Chair was recently confirmed and appreciated with particular reference to two important events: the adoption by the General Assembly of the 'United Nations Declaration on the Right to peace' (December 2016) and the adoption by the Italian Parliament of the framework-law 'on Italy's participation in international missions' (July 2016).

As far as the right to peace is concerned, the Chair played a major role in providing scientific content to the campaign conducted in Italy in cooperation with the National Coordinating-body of Local Authorities for Peace and Human Rights and the University's Human Rights Centre. The Councils of 300 Municipalities and of 6 Regions have signed the petitionary motion prepared by the Chair and the Centre. The report prepared by Ambassador Christian Guillermet Fernandez (President/Rapporteur of the Intergovernmental Working Group of the UN Human Rights Council) and his legal adviser David Fernandez Puyana makes reference to the role of the Padova Chair.

The Chair further played an important role in drafting the text of the framework-law on Italy's participation in international missions: on occasion of the hearing held at the Italian Chamber of Deputies on 16 April 2015, the Chairholder presented the proposal of the text of the first paragraph of article 1, which was substantially upheld:

"1. (...) The participation of Armed Forces, Police Forces, both military and civil, and Civil Peace Corps in international missions established in the framework of the United Nations or of other international organizations to which Italy belongs, or otherwise established in accordance with international law, including military operations and European Union's police and Rule of Law missions, as well as missions aimed at exceptional humanitarian interventions, is permitted, in accordance with the provisions of this framework-law, provided that this participation complies with the principles laid down in Article 11 of the Constitution, general international law, international human rights law, international humanitarian law and international criminal law." (...) 3. In the context of Italy's participation in international missions initiatives are taken to implement UN Security Council resolution no. 1325 (...) as well as the National Action Plan on "Women, peace and security" (italics added).

The importance of this article lies mainly in: the inclusion of Civil Peace Corps within the list of subjects legitimated to take part in international missions, the list of international legal sources, and the significance attributed to Security Council resolution no. 1325. The National Department for the Youth and Civil Service of the Presidency of the Council of Ministers has entrusted the task of organising the first three training courses for those in charge of training Civil Peace Corps to the Human Rights Centre of the University of Padova. The UNESCO Chair will participate with lectures concerning, in particular, the themes of institutional multilateralism and new forms of active states' neutrality compliant with art. 28 of the Universal Declaration of human rights, and the role of human rights defenders.

The theme of democracy and peace has been developed by the Chair with regards to four elements: the *glocal* space for the extension of the practice of democracy from local communities to multilateral institutions; the multi-level governance architecture, with particular attention to local governments and institutional multilateralism; plural and inclusive citizenship and the pioneering role of the human rights defenders; intercultural dialogue for the development of a universal human rights culture aimed at sharing new cultural expressions in accordance with the approach provided in the 2005 UNESCO Convention on the protection of cultural diversity.

Also with reference to intercultural dialogue, the approach adopted by the Padova UNESCO Chair emphasises the need to maintain a strong attention on world order problems, keeping in mind their consequences on the local communities' daily life.

The Chairholder's essay included in the UNESCO publication *Agree to differ* and entitled "Plural Citizenship and the right to peace in the agenda of intercultural dialogue: an Italian case" (pp. 109-111), has been developed in accordance with this approach. It should be recalled that the volume, which the Padova Human Rights Centre contributed to print also with a financial contribution, was presented in March 2015 at the UNESCO Headquarters, on the occasion of the First Expert Meeting on the International Decade for the Rapprochement of Cultures (2013-2022). The Chairholder participated in the meeting with a presentation.

It is also worth reporting that the music theater "We, human rights. Representation of human dignity and of peace", written by the Chairholder and published in 2016 in an Italian-English facing-page edition (Marsilio Publishers, Venice), was staged for the first time in Padova on 13 December, on occasion of the International Conference "Looking beyond the 50th Anniversary of the Covenants. What Interdependence and Indivisibility of Human Rights?", organised by the UNESCO Chair and the Human Rights Centre. Other performances are reported to have been realised in schools too.

The Unesco Chair will continue to have academic exchanges with: University of Panteion, Athens, Unesco Chair; University of Luxemburg, Unesco Chair; University of Bergamo, Unesco Chair; University of Zagreb; University of Western Sydney; University of Graz, European Training and Research Centre for Human Rights and Democracy; University of Wrocław, Poland; "Ryckevelde", (Bruges) a European and international Centre promoting European citizenship as a primary citizenship; European Inter-University Centre for Human Rights and Democratisation, EIUC; Office of the UN High Commissioner for Human Rights.

In the academic year 2016-2017 the UNESCO Chair at the Padova University will continue to provide teaching and research cooperation in the following major programmes of the University of Padova:

- the Bachelor Degree Programme in "Political Science, International Relations, Human Rights" (350 students enrolled per year),
- the Master's Degree Programme in "Human Rights and Multi-level Governance" (50 students enrolled per year),
- the Joint Ph.D Degree Programme in "Human Rights, Society, and Multi-level Governance" (Partner Universities: Padova, Zagreb, Athens, Nicosia, Western Sydney). Special cooperation will continue with the European Master in Human Rights and Democratisation (41 partner universities), especially to assist the Padova University in carry out its role as first enrolling university in the framework of the E.MA main course The Chair will continue to offer a large amount of lectures in educational and training courses and seminars in the Italian school system.

The Chair will continue to develop its work in the Veneto Region as well as in Italy and in the framework of relationships with significant international venues.

Research will be developed with reference to the following subjects:

- Italy in the universal and regional (European) systems of human rights, aimed in particular to prepare the Italian Yearbook of Human Rights (annual publication, started in 2011);
- the right to peace as a fundamental right: follow-up to the UN Declaration of December 2016:
- human rights, peace and intercultural dialogue for the inclusive citizenship;
- human rights and intercultural dialogue in the foreign policy of the EU and other international actors;
- peace, human rights, use of force: countering the states attempt to reappropriate the *ius* ad bellum:

- human rights, peace, inclusion, transnational democracy: the international role of local governments, 'city diplomacy', multilevel governance;
- the principle of complementarity and universal jurisdiction for the prosecution of international crimes;
- mixed migration flows, human trafficking and migrants' smuggling under a human rights perspective;
- violence against women as a human rights violation and form of discrimination against women: a legal and public policy analysis of States' response
- interdependence and indivisibility of human rights at the regional level from an integrated and holistic perspective;
- links and relations among religions, minorities and human rights from a multi-disciplinary perspective.

In the a.y. 2016-2017 the UNESCO Chair will continue to support three major academic publications of the Padova University Human Rights Centre:

Peace Human Rights Governance (PHRG)

The new peer-reviewed academic journal of the Human Rights Centre and of the UNESCO Chair in Human Rights, Democracy and Peace is published in English from Spring 2017 by Padova University Press, three issues per year. Launched on the occasion of the 35th anniversary of the foundation of the Padua's University Centre, PHRG aims to constitute a new scientific resource within the increasing and multi-faceted global human rights studies community. The specific aim of PHRG is to present original theoretical and empirical contributions on current human rights issues while actively favouring the development of a multi-disciplinary and multi-level approach to human rights research and dissemination. The UNESCO Chairholder is member of the Scientific Board.

Italian Yearbook of Human Rights

The UNESCO Chairholder will continue to be the Director of the prestigious *Italian Yearbook of Human Rights*, the periodic publication which annually provides a dynamic and up-to-date overview of the measures Italy has taken to adapt its legislation and policies to international human rights law and to comply with commitments voluntarily assumed by the Italian Government at the international level. The Yearbook surveys the activities of the relevant national and local Italian actors, including governmental bodies, civil society organisations and universities. It also presents reports and recommendations that have been addressed to Italy by international monitoring bodies within the framework of the United Nations, the Council of Europe and the European Union. Finally, the Yearbook provides a selection of international and national case-law that casts light on Italy's position vis-à-vis internationally recognised human rights.

Series: Human Rights Studies

Peter Lang International Academic Publishers

The series intends to foster the publication of volumes that investigate the multiple facets of a strongly evolving reality, and stimulate the production of new and innovative ideas. It

offers to highlight how the human rights paradigm is at times used and at times disregarded or exploited in cases and situations that regard among others those belonging to vulnerable groups (immigrants, asylum seekers, persons with disabilities), NGOs and human rights defenders' advocacy, intercultural dialogue, governance of world economy, bio-technologies and peace operations. Those studies which adopt inter- and transdisciplinary approaches, in accordance with the fundamental principle of interdependence and indivisibility of civil, political, economic, social and cultural rights, will be favoured.

The Padua UNESCO Chair will continue to develop its work in the framework of the communication, dissemination and multi-medial activities promoted by the Human Rights Centre through its website. Besides keeping up to date the specific section of the site devoted to the Chair and its activities, the Chair contribute through providing contents, both factual and academic, on the various areas of research listed above, also through the diffusion of "Human Rights Academic Voices", that is, brief academic comments on current relevant issues concerning peace and human rights.

International Conference on "Religions and Human Rights"

The relationship between religion and human rights is controversial and debated. The aim of the international conference is to take stock of the complex connections between religion and human rights, emphasizing that both the definition and the application of these two concepts are influenced by the different social and cultural contexts within which they are placed. Starting from the geopolitical changes which have involved contemporary society on a global scale, the conference intended to critically evaluate the two main narratives on this topic: on the one hand religions understood as an element opposing the

affirmation of human rights, and on the other religions considered as agencies facilitating the implementation of human rights. Religious rights, understood as individual and/or collective rights, are disputed as well.
